## **ST. JOHN'S HOSPITAL AND HSHS MEDICAL GROUP EXPAND PARTICIPATION WITH HEALTH ALLIANCE NETWORK**

(SPRINGFIELD, IL) –St. John's Hospital and HSHS Medical Group, including Priority Care, have expanded network participation with Health Alliance Medical Plans effective immediately. The new arrangement means local residents who enroll in Health Alliance HMO or POS insurance plans, including the State of Illinois employee health plan, will have access to the full services of St. John's Hospital and HSHS Medical Group. Both the Hospital and Medical Group already participate in the Health Alliance PPO and self-funded networks.
